THE 2016 SUMMER TAX BILLS were

mailed out to all Genoa Township property owners June 30, 2016. The Summer Taxes were due September 14th. Summer taxes are charged a 1% per month interest fee after September 14th and are payable at the Township until February 28, 2017. Taxes become delinquent March 1st and are payable, with additional 1% interest per month and a onetime 4% administration fee, to the Livingston County Treasurer, 200 E. Grand River, Howell, MI 48843, 517-546-7010.

THE 2016 WINTER TAX BILLS

were mailed out to all Genoa Township property owners November 30, 2016. The Winter tax is payable at the Township until February 28, 2017. The 2016 taxes become delinquent March 1st and are payable, with a 1% per month interest fee and a onetime 4% administration fee, to the Livingston County Treasurer, 200 E. Grand River, Howell, MI 48843, 517-546-7010. If you move or change your mailing address please notify the Genoa Township Assessor's office in writing. Failure to receive your tax bill does not waive penalties and interest.

Tax payments can be made at the Township Office by cash or check, Monday-Friday 9:00-5:00, or by mail to 2911 Dorr Rd., Brighton, MI 48116. If paying by mail please allow extra time for delivery, **postmarks are not accepted.**

Credit card and electronic check payments can ONLY be made online at www.genoa.org. Point and Pay is providing this service for the Township. They will charge a 3% convenience fee for credit card payments and a flat fee of \$3.00 for electronic check payments. **Credit card payments cannot be made at the Township.**

With online banking most banks use a

third party to process checks requested through their online bill payment system. This means that your money is deducted from your account and sent to third party processor, not directly to the designated payee. **Bills paid through** your banking system may take up to 15 business days to be received.

HARTLAND SCHOOLS ELECTION

Hartland Area Schools has scheduled an election for Tuesday, May 2, 2017. The polling location for this special election will be at the Genoa Charter Township Hall located at 2911 Dorr Road. We have made this change in an effort to save the local school district unnecessary expense—as it is less expensive to run the election from the Township Hall.

An absentee voter application will be mailed to Hartland voters in Genoa Township by the end of March. Please know that you are always welcome to vote in person and may do so on Tuesday, May 2nd at the Township Hall. Only 110 registered voters out of 690 participated in the last election for Hartland Schools. Decisions related to local schools are important; please exercise your right to vote.

BEWARE OF SEASONAL IRS SCAMS

The Internal Revenue Service is warning taxpayers against telephone scammers targeting students and parents during the back-to-school season and demanding payments for non-existent taxes, such as the "Federal Student Tax." It is important for taxpayers to be particularly aware of this scheme going after students and parents.

The IRS will never call to demand immediate payment using a specific payment method. Generally, the IRS will first mail you a bill if you owe any taxes. If you get a suspicious phone call from someone claiming to be from the IRS and asking for money, make sure you:

- •Do not give out any information. Write down the telephone number, date, time and topic of the call.
- •Contact TIGTA to report the call. Use their "IRS Impersonation Scam Reporting" web page or call 800-366-4484.
- •Report it to the Federal Trade Commission. Use the "FTC Complaint Assistant" on FTC.gov. Please add "IRS Telephone Scam" in the notes.

CHILSON HILLS CEMETERY/ HERBST ROAD CEMETERY

Our Chilson Hill Cemetery is over 165 years old and there are no longer any full burial sites available. The Township has been searching for a possible site for a new cemetery for the last few years. We recently purchased 122 graves sites from the Saint George Lutheran Church in an effort to accommodate Township residents. The new Genoa Cemetery will be called the Herbst Road Cemetery. It is located on Herbst Road between Dorr Road and Grand River. Burial sites are now available for sale through the Township. The cost for a single site is \$400.00 for Township residents and \$600.00 for persons living outside the Township. The graves sites allow for a full burial, a full burial and one cremation, or two cremations.
