Basic Tactical Medical training offered at the Township

Genoa Township is offering "Basic Tactical Medical Training: Stop the Bleed" provided by the Livingston County Sheriff's office as part of Genoa Township's Citizen Enrichment Training. This will take place in the Boardroom from 6-8 p.m. on Monday February 23, 2026.

Class size is limited to 55 people. Township residents will have priority when registering.

Tax Information

The last day to pay 2025 Summer and Winter Property Taxes at Genoa Township is Monday March 2, 2026.

The 2025 Winter Tax Bills were mailed to all Genoa Township property owners on Monday December 1, 2025. Winter taxes are payable, without penalty, through Monday, March 2, 2026.

The 2025 Summer taxes were mailed July 1, 2025 and were payable, without penalty, through September 15, 2025. Summer tax payments can be paid, plus penalty, at Genoa Township until Monday, March 2, 2026. Please contact the Township, or check our website, for your current amount due.

Genoa Township / Brighton Senior Center Voucher Program

What is Covered: The full \$25 cost of a new Basic membership to the Brighton Senior Center

- Residents can choose to cover any additional fees to upgrade to a Silver or Gold level membership if they so choose.
- There are no reimbursements for memberships that have already paid for this year, however, if the program is extended next year, residents will be able to get a voucher for a renewal at that time.

How It Works: Residents must first come to the Clerk's Counter at the Genoa Township Hall 2911 Dorr Road, Brighton, MI 48116 to verify residency, please bring a picture ID. Once verified, you will be given a voucher to take to the Brighton Senior Center, 125 S. Church St., Brighton, MI 48116. They will then sign you up for a membership and collect the voucher.

Help for Livingston County veterans

Livingston County Veteran Services (LCVS) offers a variety of programs and services to assist veterans and their families. LCVS employs nationally accredited Veteran Service Officers to assist veterans in filing for US Dept. of Veterans Affairs benefits. Honorably Discharged veterans registered with LCVS, and their spouse may utilize complimentary LCVS transportation to medical appointments within a 50-mile radius. To schedule a ride, call LETS at (517) 546-6600, select option 3 and mention veteran status. LCVS offers Honorably Discharged veterans who are less fortunate several assistance programs provided by Emergency Relief funds, such as:

- \$200 food and toiletry voucher plus an additional \$50 for each child in the household,
- \$200 clothing vouchers for their school-aged children up to age 18,
- \$50 Speedway fuel only cards; and
- Dental assistance of up to \$1,000 via LCVS partnership with VINA Dental.

Call (517) 546-6338 to set up an appointment and qualify for these programs.
