MINUTES

Supervisor McCririe called the regular meeting of the Genoa Charter Township Board to order at 6:30 p.m. The Pledge of Allegiance was then said. The following persons were present constituting a quorum for the transaction of business: Gary McCririe, Paulette Skolarus, Robin Hunt, Todd Smith, Jean Ledford, Steve Wildman and Jim Mortensen. Also present were Township Manager Michael Archinal and five persons in the audience.

A Call to the Public was made with no response.

Approval of Consent Agenda:

Moved by Smith, supported by Ledford, to approve all items listed under the consent agenda as requested. The motion carried unanimously.

- 1. Payment of Bills
- 2. Request to approve minutes: 4-19-10
- 3. Consider approval of security cameras and paving for the Genoa Athletic Field Pavilion.
- 4. Consider approval of a proposal from Tom Rogers Asphalt for repairs at the Nielsen Fire Station.
- 5. Consider approval of a proposal for the installation of Township entrance signs.

Approval of Regular Agenda:

Moved by Ledford, supported by Wildman, to approve for action all items listed under the regular agenda as requested. The motion carried unanimously.

6. Discussion regarding the Dillon Water Agreement PILOT charge.

Mr. John Johnson addressed the board concerning the PILOT charges that have been incurred over the past 18 years. Johnson – Originally there were 89 units that were involved in the first agreement with the City of Brighton. That system costs the city zero dollars since the state provided over \$750,000.00 for the project. In the end the state paid more than one million dollars. The well on Challis Road was at one time in Genoa Township and the Township gave it to the city. We already pay an additional 10% for our water usage. We should not be charged \$100.00 just because we are outside of the city.

Archinal – There is some question regarding the legality of such charges. A township law E-Letter speaks to a case in Grand Ledge that is on point. Basically if there are premiums charged to customers outside a jurisdiction those charges have to be based upon the incremental added cost of providing the service. They cannot be arbitrary.

Moved by Smith, supported by Hunt, to authorize the manager to approach the City of Brighton to discuss the concerns raised by Mr. Johnson in the hopes of settling the matter amicably. The motion carried unanimously.

7. Consider first reading of an ordinance to designate Genoa Charter Township as an enforcing agency for the Michigan Construction Code.

Moved by Ledford, supported by Mortensen, to approve the first reading of Ordinance 100517 as presented. The motion carried by roll call vote as follows: Ayes – Ledford, Smith, Hunt, Wildman, Mortensen, Skolarus and McCririe. Nays – None. Absent – None.

8. Discussion regarding ribbon cutting ceremony for the Genoa Athletic Field Pavilion.

It was the consensus of the board to hold a ribbon cutting ceremony on June 7, 2010 at 6:00 p.m. to dedicate the new gazebo and soccer fields. This ceremony will honor Mr. Un Chong and thank Mrs. Christine Vogt for her generous donation on behalf of her husband Mr. Chong.

The board approved the purchase of four picnic tables and three receptacles at a total cost of \$4,840.00 for the completion of the gazebo.

The regular meeting of the Genoa Charter Township Board was adjourned at 7:10 p.m.

Genoa Charter Township Ordinance#: 100517

An ordinance to designate an enforcing agency to discharge the responsibility of Genoa Charter Township, under the provisions of the Stille-DeRossette-Hale Single State Construction Code Act, 1972 PA 230, MCL 125.1501 et seq.

The Genoa Charter Township ordains:

Section 1. AGENCY DESIGNATED. Pursuant to the provisions of the Michigan (Building, Electrical, Mechanical or Plumbing) Code, in accordance with Section 8b(6) of 1972 PA 230, the (Building, Electrical, Mechanical, or Plumbing) Code Official of Genoa Charter Township is hereby designated as the enforcing agency to discharge the responsibility of the Genoa Charter Township under 1972 PA 230, State of Michigan. Genoa Charter Township assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.

Section 2. REPEALS. All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

Section 3. PUBLICATION. This ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.

Dear Mr. Derian Campos:

Pursuant to Section 9f of Public Act 206 of 1893, the General Property Tax Act, the Department of Treasury received the New Personal Property Exemption resolution submitted for CRW Plastics USA, Inc., 214-2009, in the Township of Genoa, Livingston County. Section 9f(1) states, in part, that "the governing body of an *eligible local assessing district* may adopt a resolution to exempt from the collection of taxes under this act all new personal property..." [Emphasis added].

The State Tax Commission, at their April 26, 2010 meeting, considered the CRW Plastics USA, Inc. resolution. After consideration, it has been determined that the Township of Genoa is not an *eligible local assessing district* as defined in Section 9f(7)(g). Therefore, since the Township of Genoa is not eligible to adopt such a resolution, the request for the New Personal Property Exemption has been denied.

A party aggrieved by the issuance, refusal to issue, revocation, transfer, or modification of a new personal property exemption may appeal the finding within 30 days to the Michigan Tax Tribunal.

Hartland adds road millage to ballot

Proposal would bring in about \$617K a year for improvements

Hartland Township has approved a millage question to be added to the Aug. 3 election ballot that would generate funds for pathway and road improvements for the township.

The five-year 1-mill proposal would generate approximately \$617,000 a year for five years.

A homeowner with an average taxable value of \$160,000 would pay about \$160 annually under the millage.

Township Manager James Wick-

man said funding from the Livingston County Road Commission is dwindling while Hartland Township roads continue to deteriorate. He said the township isn't advocating for or against the proposal, but that the township wants to provide residents an opportunity to decide for themselves.

"We're seeing Road Commission funds continue to decline. That's just the way it is, and we're stuck with road conditions deteriorating," Wickman said. "The residents have made it quite clear that they're looking for the township to make something happen to

improve the condition of the roads. The township isn't advocating, we're just trying to be responsive to our residents."

Ĥartland Township will host two town-hall meetings to discuss the proposal. The meetings will take place at 7 p.m. Tuesday and at 7 p.m. June 15 at the Township Hall, 2655 Clark Road in Hartland Township.

If approved, the primary objective of the funds generated from the millage would be to protect existing street lighting and incorporate road chloride applications again — the township first made cuts to road chloride applications

two years ago, and cut applications again this year. Wickman said instead of two applications per year, the township could increase to four or even five applications, which would keep dust under control for many local roads.

If the milage passes, the township would also pave a 1.25-mile portion of Bergin Road east of Hacker Road. Wickman said Bergin Road is heavily traversed and has experienced drainage issues, among other problems, leading to vehicle accidents.

Other road projects that would likely receive attention would be

paving Hacker Road — which Hartland Township shares with Oceola Township — and a two-mile stretch of Clyde Road, east of Hartland Road to Fenton. Wickman said the plan for Clyde Road would be to add eight inches of limestone supplemental treatment to it.

"One of the big goals of the whole overall plan is to provide alternate local routes to residents so they don't have to always rely on M-59 at rush hour," Wickman said. "They could go down local routes east, west, north or south without congesting one specific area of traffic."

Wickman said he's spoken with

residents who approve and residents who disapprove of the millage, but added that township governmental units in Michigan are not set up to deal with road issues.

"It's a potential solution identified, so we're putting it before voters to see if they want to enact a millage to help solve some of these problems." Wickman said.
